

The position is simple: on January 13, 2017, the Netherlands launched an attack on my life because they do not wish to be held accountable for the sexual and financial exploitation of vulnerable youths whom you hand over/trade under false pretenses to a human trafficking organization facilitating illegal prostitution, and money earned by stealing public funds and real estate from you as government representatives and officials of the Rotterdam department (January 13, 2017). This concerns the Dutch government directly stripping me of my housing and finances because they do not wish to hear that I exercised my freedom of expression regarding the incident on October 23, 2016 (the beginning of the 10-year state war) after hearing that a fellow resident had been raped again by a pedophile disguised as a care worker and an equally disguised

pedophile. This is the Dutch government, acting here as the national spokesperson, stealing money and housing intended directly for rights holders like me, and distributing it to human traffickers, fraudsters, johns, pedophiles, and serial rapists to finance their human trafficking operation—as housing for johns and as brothels—while I have been held hostage for 7 years with housing issues as the excuse. This is the Dutch government financing a human trafficking organization with fraud and theft committed by the government collectively, including against me and the rest of the Netherlands. This is the Dutch government forcibly raping young people with intellectual disabilities and/or mental disorders, forcing them into group gangbangs, forcing them into daily anal sex without extra charge—exploitation, human trafficking, emotional

abuse, and incitement to prostitution— acting as the spokesperson for the country and the national government, yet the government does not wish to be held accountable for this? Is this going too far for the Netherlands? A violation of the fundamental right to sexually/financially exploit a person in need? This results in a “prison sentence” of 7 according to the Dutch State (January 13, 2017), signed and signed by the Minister of Legal Protection and the King of the Kingdom of the Netherlands.

I have been doing nothing else for 10 years than trying to restore the conscience and the rule of law of the country that was lost on October 23, 2016, because they “felt threatened” in the thought that they could no longer continue anal-raping vulnerable youths and those in need of care who were recruited by the Dutch government based

on their intellectual disability and other psychological and/or psychiatric issues. That you “might now face consequences” for sexually and/or financially portraying vulnerable youths as fraudsters/ pedophiles/serial rapists disguised as care workers, or “can be held accountable” for it following complaints from fellow residents. We are talking here about the government that is guilty of violating the United Nations Convention against Transnational Organized Crime, steals my housing, financially robs me for 10 years using corrupt officials, and when I ask for justice, also has me abducted for 7 years, and justifies all of this and considers it justified because of the intervention on October 23, 2016, in their illegal prostitution-facilitating human trafficking/rape operation financed with, among other things, the money for my housing and

stolen healthcare funds by speaking out about this? Exercising my right to freedom of speech just as you exercise your right to freedom to rape? As long as the Netherlands continues to violate my human rights and persists in claiming that stealing (including from me), rape, abuse, hunting to death, mistreating, exploiting, fraud, forgery, and perjury is a legitimate reason in the Netherlands to launch an attack on someone's life, render them homeless, financially rob them, and abduct/hold hostage/kidnap them for 7 years without any legal grounds, and justifies these violations of international law, fundamental rights, human rights, the Council of Europe Convention on Combating Trafficking in Persons, and the European Convention for the Protection of Human Rights and Fundamental Freedoms for sexual gain, I will be held accountable

for compensation for this injustice inflicted upon me for 10 years by one of the richest countries in the world, but you do not want to spend more than €2.50 on your human trafficking operation and you steal the rest from the homeless children/youth fund and from me? Just like my housing? You give away 10 billion in taxpayer money without hesitation on bombs for a war that isn't the Dutch one, but you don't have 1 million left for the restoration of the rule of law? The credibility of the Dutch government and judiciary? The reputation of the entire country that you represent as a recruiter for a human trafficking organization that has been screwing you over for 10 years? The signal that the Netherlands, as a country and government, does not support financing human trafficking operations with stolen money and housing for

homeless children/young people? That the Netherlands is finally distancing itself, after 10 years, from forced anal sex, gang rapes, and the sexual and financial exploitation of young people with intellectual disabilities and/or other psychological/psychiatric disorders? That being accused of abusing young people in need of care and assistance is no reason for a national declaration of war, that the Netherlands still stands behind the Constitution and the rule of law, while respecting human rights, international and European treaties and protocols regarding decency, and does not once again make a fool of all of Europe and me because the possibility exists for impunity for human trafficking and commercial rapes.

Thinking deeply of everything I have experienced in those 10 years in my fight for justice, which continues to this day due

to years of being held hostage, I would have asked for 1 million per year for robbing my money and freedom for sexual and financial gain. This 1 million is what the law grants me a legal right to. This is therefore the legally established amount, not what I understand by “compensation for damages.”

For the will/urge to rape teenage girls can never be a reason to deprive a human being of his human rights, €1,000,000, and right of freedom of speech.
